Monday, 2 December 2013 was a monumental occasion for Cochrane Canada as Dr Jeremy Grimshaw, Director of the Canadian Cochrane Centre and Co-Chair of The Cochrane Collaboration, was presented with the Canadian Institutes of Health Research (CIHR) Knowledge Translation Award. This was one of four awards presented during the Canadian Health Research Awards, which was hosted by His Excellency the Right Honourable David Johnston, Governor General of Canada, at Rideau Hall.

In attendance was the Honourable Rona Ambrose, Minister of Health, and Dr Alain Beaudet, President of CIHR. Fellow award winners include Dr Christian S Hendershot for The Peter Lougheed/CIHR New Investigator Salary Award, Dr Bonnie Leadbeater for the CIHR

Partnership Award and Dr Gordon H Guyatt for Canada's Health Researcher of the Year. Dr Guyatt is also involved in Cochrane as a Co-Convenor of the Patient-Reported Outcomes Methods Group.

Cochrane Canada was granted with the CIHR Knowledge Translation Award based on its significant contributions to global health knowledge through the production of systematic reviews and plain language summaries. Introducing the Québec Branch of the Canadian Cochrane Centre

The Québec Branch of the Canadian Cochrane Centre (CCC) was founded in September 2013 at Le Centre Hospitalier Universitaire de Québec (CHUQ) and is one of 21 branches worldwide. The Branch will work closely with the Cochrane Canada entities and contribute to the promotion of The Cochrane Collaboration in French within Canada.

The Branch's commitment to the Collaboration is based upon three guiding principles: access to training services in French, providing support for an increased production of Cochrane Reviews and expanding the dissemination of evidence syntheses. It is also important to innovate and enhance the development and promotion of methodologies required for the production of high-level knowledge syntheses that ultimately reflect the excellence of our research community. Finally, the Branch will help position CHUQ as a reference centre for knowledge syntheses, thus contributing to CHUQ's reputation as the largest francophone centre for health research in North America.

The Branch is pleased to combine its efforts with international donors to imple-

ment services and resources to support researchers, clinicians, professionals and managers to reach and educate the general public, the news media and experts in developing health policy.

The Team

The direction of the Québec Branch of the CCC will be provided by Drs Légaré and Fortin. Coordination and development of activities will be provided by Nadine Tremblay, assisted by William Witteman, information specialist.

Dr France Légaré, Scientific Director

A family physician working in Québec City since 1990, Dr Légaré is a professor in the Department of Family Medicine and Emergency Medicine at l'Université Laval. Since June 2006, Dr Légaré has held the title of Canada Research Chair in Implementation of Shared Decision Making in Primary Care. Her research aims to provide healthcare professionals and patients with the tools necessary to optimize decision-making in the primary care setting. To date, she has published 166 peer-reviewed articles.

Over the past 14 years, Dr Légaré has been the representative of the Canadian

Cochrane Centre's Regional Site at l'Université Laval, advocating for health care, evidence-based medical practice and academic research communities in Québec.

Dr Paul R Fortin, Co-Director

Dr Paul Fortin is a Professor with the Faculty of Medicine at l'Université Laval and holds a Master's in Public Health and a Diploma in Clinical Epidemiology from Harvard University. As Canada Research Chair in systemic autoimmune rheumatic diseases and Deputy Director of Clinical Research at CHUQ, Dr Fortin is determined to support the activities of the Branch. His work in systemic rheumatic diseases is patient-centered and aims to improve clinical outcomes as well as practice. Dr Fortin has 181 peer-reviewed publications.

Nadine Tremblay, Coordinator

Nadine Tremblay has assisted in the implementation of training activities since her appointment at CHUQ in January 2009. The work of Ms Tremblay has included:

- Supporting author teams and participating in the conduct of systematic reviews
- Organizing, conducting and evaluating training activities
- Developing and disseminating training material

Ms Tremblay will now act as the Cochrane Knowledge Synthesis Coordinator for the Branch and work to consolidate and develop activities for increased visibility.

William Witteman, Information Specialist





The Nova Scotia Cochrane Resource Centre's involvement in new Cochrane Review types: Prognosis Systematic Reviews

Prognosis research can inform the course of a condition, the relationship between a prognostic factor and outcome, clinical diagnosis and healthcare decision making. The Cochrane Collaboration Steering Group

has approved the registration of three Prognosis 'Exemplar' Reviews to assess the feasibility and provide examples of these innovative types of systematic reviews. The prognostic factor exemplar review, "Individual

recovery expectations and prognosis of low back pain: Prognostic factor exemplar review", and related methodological work is being conducted by an international team including three members from

the Nova Scotia Cochrane Resource Centre: Jill Hayden, Michelle Tougas and Robin Parker. This project is described in the box below.

Hayden JA, Tougas, M, Iles, R, Riley RD, Pincus T, Saunders R, Parker RM. Individual recovery expectations and prognosis of low back pain: Synthesis and implementation of prognostic factor evidence. Canadian Institutes of Health Research, Knowledge Synthesis Competition, 2013-2014.

Prognostic research is important for identification of factors associated with outcome for patients with low back pain. This exemplar review will systematically investigate the available evidence about the association of one prognostic factor—individual recovery expectations—with the outcome of low back pain. Individual recovery expectations are what a patient 'expects to occur' with respect to their health condition over time.

This project is funded by the Canadian Institutes of Health Research. In addition to the Cochrane exemplar review, the team will explore methodological approaches of prognosis systematic reviews for literature searching and risk of bias assessment. The title of the prognostic factor exemplar review has been registered with the Cochrane Back Review Group, and the protocol was submitted to Cochrane for review in July. We are currently completing the recommended protocol revisions. The timeline for the project is 12-18 months – stay tuned to hear about its progress!

Cochrane Training & Professional Development Strategy

Cochrane Training is in the process of developing a comprehensive Cochrane Training and Professional Development Strategy to be delivered to The Cochrane Collaboration Steering Group in September 2014.

The Strategy will encompass:

- Training and support of contributors ('training'): primarily aimed at authors and editors, enabling the

production of high-quality reviews (corresponds to Goal one of the Cochrane Strategy to 2020).

- Professional and leadership development: primarily aimed at a more 'internal' group comprising staff of Cochrane groups, trainers, leaders such as Co-ordinating Editors (and their potential successors), and centrally funded staff.

These groups are essential to the long term sustainability of the organization (corresponds to Goal 4 of the Cochrane Strategy to 2020).

The Strategy development process will be overseen by a Project Board, chaired by David Tovey, Editor in Chief of *The Cochrane Library*. Two Working Groups comprised of a range of stakeholders in training

activities will lead the consultation and drafting work. We will consult widely within the Collaboration and with key advisors to develop the Strategy. Education and Training 2012-2013

An excerpt from the 2013 Cochrane Canada Annual Report

Workshops

In the past year, the Canadian Cochrane Centre (CCC) has expanded the number and geographic spread of its face-to-face training sessions, adding sessions in St. John's, NL and Saskatoon, SK for the first time. Demand for Cochrane Standard Author Training Workshops continues to outpace the CCC's ability to deliver sessions. Looking forward, the CCC will work with the new Québec Branch of the Canadian Cochrane Centre to build both training and systematic review capacity amongst Canadian Francophones.

Webinars

In the past year, CCC webinars have focused on a wide range of topics that are relevant

to people with beginner or advanced knowledge of The Cochrane Collaboration, Cochrane Reviews and *The Cochrane Library*. In the 2012-2013 period, the CCC emphasized francophone outreach by presenting webinars in French. Though the French webinars were not as popular as the English webinars, it's expected that francophone participation will increase in the coming years through collaboration with the new Québec Branch of the Canadian Cochrane Centre. The CCC continues to significantly exceed its webinar targets overall and has increased its participation substantially in the last year. The Nova Scotia Cochrane Resource Centre has developed a value-added com-

ponent to the *Cochrane Canada Live!* webinar program: each webinar is broadcast live to a group of engaged stakeholders and students who follow the webinar with a face-to-face discussion moderated by Dr Jill Hayden, an experienced Cochrane methodologist and Resource Centre lead. This past year, three such sessions were held at Dalhousie University in Nova Scotia. Cochrane Canada thanks the Pan American Health Organization/World Health Organization for providing the Blackboard Collaborate™ platform to make these webinars possible.

Training needs assessment for Managing Editors: results of the online survey

In February 2013, the Cochrane Training Working Group contacted all Cochrane Managing Editors (MEs) and Assistant Managing Editors (AMEs) to encourage them to complete an online training needs assessment survey to identify those areas where training opportunities were desired to meet their training needs.

There was a good response rate, with responses from MEs or AMEs in 48 (90.6 per cent) out of 53 Cochrane Review Groups (CRGs). The survey looked at priority training areas across all

CRGs and in different geographical areas, and by the years of experience as a Cochrane ME or AME. When combined, the top three priority areas are: (1) Methodological Expectations of Cochrane Intervention Reviews (MECIR); (2) Plain language summaries; and (3) Summary of findings tables/GRADEpro.

A report can be found at training.cochrane.org/entity-staff/mes and includes the full set of results and describes the next steps. As noted in the report, the Training Working Group is working on a website

that will house all the ongoing, planned, and recorded training activities in the priority training areas, and use this to identify gaps and then make plans to develop and deliver training in these areas. An early version of the website can also be found at training.cochrane.org/entity-staff/mes.

The Training Working Group would like to hear from any Centres or Branches interested in organizing events or resources for MEs, and hopes it can harness any local efforts to build broader support for MEs internationally.
